

LINN COUNTY BOARD OF SUPERVISORS  
CEDAR RAPIDS, LINN COUNTY, IOWA  
MONDAY, JULY 2, 2018 9:00 A.M.

The Board met in session at the Linn County Jean Oxley Public Service Center.  
Present: Chairperson Harris, Supervisor Rogers and Oleson. Absent: Vice Chairperson Houser and Supervisor Walker (personal business). Board members voting "AYE" unless otherwise noted.

Chairperson Harris called the meeting to order.

Motion by Rogers, seconded by Oleson to approve minutes of June 27, 28 & 29, 2018 as printed.

A public hearing was called to order for an ordinance amending Chapter 10 of the Code of Ordinances by adding thereto a New Article VII Pertaining to the Control of Lead-Based Paint Hazards. Proof of publication was presented. There were no oral or written objections.

Ruby Perin, Public Health, presented the ordinance which will allow Public Health to intervene when a child is lead poisoned.

Motion by Rogers, seconded by Oleson to close public hearing.

Motion by Rogers, seconded by Oleson to approve upon first consideration Ordinance Amending Chapter 10 of the Code of Ordinances, Linn County, Iowa, by Adding Thereto a New Article VII Pertaining to the Control of Lead-Based Paint Hazards.

Darrin Gage, Dir. of Policy & Admin., presented an ordinance amending the Code of Ordinances by Repealing and Replacing Provisions in Chapter 20, Article III Relating to the Linn County General Assistance Program. He stated that when the code of ordinances was recodified, the wrong ordinance was included.

Motion by Rogers, seconded by Oleson to approve upon first consideration ordinance amending the Code of Ordinances, Linn County, Iowa, by Repealing and Replacing Provisions in Chapter 20, Article III Relating to the Linn County General Assistance Program.

Gage also presented some language clean up for an ordinance amending the Code of Ordinances by Amending Provisions in Chapter 20, Article II and Adding a Provision in Chapter 20, Article II Pertaining to the Department of Community Services.

Motion by Rogers, seconded by Oleson to approve upon first consideration an ordinance Amending the Code of Ordinances, Linn County, Iowa, by Amending Provisions in Chapter 20, Article II and Adding a Provision in Chapter 20, Article II Pertaining to the Department of Community Services.

Motion by Rogers, seconded by Oleson to award bid and authorize chairperson to sign contract and associated documents for Linn County project M-HMA PATCHING(19), HMA patching at various locations, to LL Pelling Co., Inc., in the amount of \$818,796.60.

Gloria Witzberger, Child Development, presented a contract for services with the Linn County Early Childhood Iowa Board on behalf of Linn County Community Services Child & Youth Development, for the Nurturing Parenting program. The Board will approve tomorrow.

Luke Maloney and Stephanie Lientz, Planning & Development, presented a resolution rescinding the appointment of Leslie T. Beck as Interim Building Official of the Planning and Development Department and a resolution appointing Luke Maloney as Building Official of the Planning and Development Department. The Board will approve tomorrow.
