MONDAY, JULY 9, 2018 9:00 A.M.

The Board met in session at the Linn County Jean Oxley Public Service Center.
Present: Chairperson Harris, Vice Chairperson Houser, Supervisor Rogers, Oleson and Walker. Board members voting "AYE" unless otherwise noted.

Chairperson Harris called the meeting to order.

Motion by Rogers, seconded by Walker to approve minutes of July 3, 2018 as printed.
VOTE: Harris, Rogers, Oleson, Walker - Aye Houser - Abstain.

Motion by Rogers, seconded by Houser to approve upon third and final consideration Ordinance #6-7-2018, amending Chapter 10 of the Code of Ordinances, Linn County, Iowa, by Adding Thereto a New Article VII Pertaining to the Control of Lead-Based Paint Hazards.

Motion by Rogers, seconded by Oleson to approve upon third and final consideration Ordinance #7-7-2018, amending the Code of Ordinances, Linn County, Iowa, by Repealing and Replacing Provisions in Chapter 20, Article III Relating to the Linn County General Assistance Program.

Motion by Houser, seconded by Rogers to approve upon third and final consideration Ordinance #8-7-2018, #8 amending the Code of Ordinances, Linn County, Iowa, by Amending Provisions in Chapter 20, Article II and Adding a Provision in Chapter 20, Article II Pertaining to the Department of Community Services.

Public Comment: Janet Pilcher stated that she is in favor of a road name change that is on the agenda next week. She stated that Witwer Lane is an historic name and is appropriate. She asked how soon this would happen and Supervisor Oleson stated that the County Engineer will be able to answer questions next week.

Joi Alexander, Communications Dir., met with the Board to discuss the Linn County brand style guide and use of the new Linn County logo. Two exceptions is Conservation and Public Health but they will include the new logo. The County Attorney and Sheriff are open to incorporate the new logo as well. Alexander recommends proceeding with the roll out without the Sheriff and County Attorney at this time. A lengthy discussion followed regarding the usage request form by third parties and whether or not an example should be provided prior to approval.
