

LINN COUNTY BOARD OF SUPERVISORS  
CEDAR RAPIDS, LINN COUNTY, IOWA  
MONDAY, AUGUST 13, 2018 9:00 A.M.

The Board met in session at the Linn County Jean Oxley Public Service Center.  
Present: Chairperson Harris, Vice Chairperson Houser (via phone), Supervisors Rogers, Oleson and Walker. Board members voting "AYE" unless otherwise noted.

Chairperson Harris called the meeting to order.

Motion by Rogers, seconded by Walker to approve minutes of August 8, 2018 as printed.

Sheriff Brian Gardner and Maj. Doug Riniker met with the Board for a continuation of a discussion regarding a request for three additional deputy sheriffs for the Correctional Center. The three additional deputies would help to reduce the amount of forced overtime (to keep staff and inmates safe) due to the jail being at capacity. The revenue for housing the federal inmates offsets the cost of the deputies. Gardner stated that he has met with Steve Tucker, Dawn Jindrich and Brent Oleson.

Discussion continued regarding the future of the jail including adding on to the existing building, building new or repurposing an existing building.

Supervisor Rogers asked how long it would take to hire additional deputies if the request is approved and Gardner responded that people are eligible on an existing list. The Board will make a decision on Wednesday.

Motion by Rogers, seconded by Walker to authorize Supervisor Brent Oleson to sign, retroactive to August 8, 2018, a letter to the National Endowment for the Arts supporting Marion's grant submission for Phase II of the Uptown Artway project.
