

LINN COUNTY BOARD OF SUPERVISORS
CEDAR RAPIDS, LINN COUNTY, IOWA
MONDAY, JUNE 17, 2019 10:00 A.M.

The Board met in session at the Linn County Jean Oxley Public Service Center.
Present: Chairperson Walker, Vice Chairperson Rogers and Supervisor Oleson. Board members voting "AYE" unless otherwise noted.

Chairperson Walker called the meeting to order.

Motion by Oleson, seconded by Walker to approve minutes of June 12, 2019 as printed.

Kevin Wormwood, Dist. Mgr. of Junior Achievement of Eastern Iowa, presented a funding request in the amount of \$20,503.12 from the economic and community development fund.

Paula Freeman-Brown, Mayor of Center Point, gave a presentation for economic and community development funding in the amount of \$35,000 (and will come back for two additional years) for a new fire station. The total cost is \$2.7 million. The City will have a bond issue in November and they are fundraising. Also going after a FEMA grant for a safe room. Also present: Joe Moore, Asst. Fire Chief, Ted Beuter, Washington Twp. Trustee, Tracy Tritle and Linda Langston.

Supervisor Rogers explained his experience on the Mt. Vernon volunteer fire department and understands the challenges of a small town.

Tom Hardecopf, LIFTS Dir., presented a contract for ADA Complementary Paratransit Service between Linn County (LIFTS) and Cedar Rapids Transit (City of Cedar Rapids) for Fiscal Year 2020 in the amount of \$861,240. The Board will approve on Wednesday.

Rhonda Betsworth, Deputy Auditor, explained a Business Property Tax Credit correction for 2017 and 2018 (adding one parcel). The Board will approve on Wednesday.

Motion by Rogers, seconded by Oleson to authorize Chair to sign, retroactive to June 13, 2019, a letter of support for EMBARC's (Ethnic Minorities of Burma Advocacy and Resource Center) Ethnic Self-Help Grant application.

Mike Tertinger, Planning & Development, presented a proposed Temporary Use Permit, Case JTU19-0006, request by Karl Haible, owner, and West Linn Community Group, petitioner, for the Palo Mud Run event on June 15th, 2019, at 812 Iowa Ave. The Board will approve retroactive to June 15 on Wednesday.

Tertinger has been asked by the Board to explore making the Temporary Use Permit process more efficient for those events that occur year after year.
